RIVER MURRAY FLOW REPORT

This supersedes the previous flow report issued by the Department for Environment and Water (DEW) on 21 December 2018. The next report will be provided on Friday 18 January 2019.

In this report, for ease of representation, large volumes of water are expressed in gigalitres (GL), while smaller volumes are expressed in megalitres (ML). One GL is equal to 1 000 ML.

NSW ALGAL BLOOM

Currently, there is a blue-green algal bloom and major fish kill in the lower Darling River. This is a result of dry conditions, low flows and high temperatures. There is no risk of this algal bloom and fish kill having an impact on South Australia. This is because there is no flow from the Darling River into the River Murray and flowing to South Australia.

FLOW OUTLOOK

The flow at the South Australian border is approximately 9.3 GL/day and will decrease to around 7.6 GL/day during the coming week. It comprises:

- normal January Entitlement Flow of 7 GL/day;
- less deferred water;
- plus environmental water; and
- interstate trade adjustments.

The flow over Lock 1 is approximately 5.9 GL/day and will decrease to around 4.5 GL/day during the coming week, depending on weather conditions and extractions.

It is important to note that flow forecasts in this advice are based on the information available at the time of preparation. Advice may change as new gauging information becomes available, or due to rainfall events or changed operations upstream.

ENVIRONMENTAL WATER

Early in January, environmental water will be delivered to South Australia at a rate of approximately 0.5 GL/day, following a small 'pulse' over the Christmas and New Year period, which included return flows from upstream environmental watering in the Mid Murray.

Environmental water is being delivered:

- to provide habitat for fish and contribute to improved water quality;
- for a range of outcomes at wetlands in the Riverland via arrangements with the Nature Foundation SA,
 SA Murray-Darling Basin Natural Resources Management Board and at Banrock Station; and
- to the Lower Lakes to protect water levels while providing for ongoing releases to the Coorong during summer (for further details see *Barrage Operations and Water Levels in the Lower Lakes* section).

MURRAY MOUTH

Dredging operations at the Murray Mouth commenced on 9 January 2015 to maintain connectivity (exchange of water) between the Coorong and the Southern Ocean.

Two dredges are operating 24/7 in the Goolwa and Tauwitchere channels. At 6 January 2019, a total of approximately 3 860 555 cubic metres of sand had been removed by dredging operations. Barrage releases combined with dredging have helped to maintain connectivity of the Murray Mouth.

There are a number of shallow zones in and adjacent to the Murray Mouth. Mariners should use caution when traversing the mouth area, follow all directions, reduce speed and avoid travelling at low tide. Mariners

equipped with echo sounders should check depths regularly. Navigation through the Murray Mouth is only permitted during daylight hours. Exclusion Zones established around the dredging operations are in place to ensure public safety. Refer to Notice to Mariners No 42 of 2016 Notice 42.

There is a partial park closure in place for the northern tip of the Coorong National Park. For more information visit Coorong partial park closure notice

BARRAGE OPERATIONS AND WATER LEVELS IN THE LOWER LAKES

The water level in Lake Alexandrina is approximately 0.69 m AHD and Lake Albert is approximately 0.64 m AHD. When possible, water levels are being managed to achieve a target water level of between 0.6 m AHD and 0.7 m AHD by the end of January 2019.

During the week ending 8 January 2019 total barrage releases were approximately 3.5 GL. All fishways remain open. During adverse weather conditions SA Water will operate the barrages to minimise the risk of seawater entering Lake Alexandrina, therefore minimising any negative salinity impacts from reverse flow events.

Water levels and barrage operations are monitored closely by the South Australian Government, Murray-Darling Basin Authority and Commonwealth Environmental Water Office.

NAVIGATION ISSUES

Sandbars in the vicinity of the Murray Mouth may cause navigation hazards. Mariners are advised to navigate with caution when operating in the area. Sandbars are also present along sections of the River Murray downstream of Locks 7 and 8 and in South Australia. All Mariners should be aware of the risk of submerged navigation hazards, and should regularly check river depth.

RIVERINE RECOVERY CONSTRUCTION WORKS

The Riverine Recovery Project is in the process of constructing environmental regulators to manage a number of wetlands between Mannum and Murtho. Construction is expected to be completed around the end of March to April 2019.

SOUTH AUSTRALIAN RIVERLAND FLOODPLAINS INTEGRATED INFRASTRUCTURE PROGRAM (SARFIIP) CONSTRUCTION WORKS

The construction of regulating structures and a blocking bank on the Pike Floodplain has commenced. The works are expected to be completed by December 2019. The works will enable:

- a portion of the floodplain to be inundated more regularly to improve ecological health; and
- fish to move freely between the River Murray and the floodplain.

During the construction period, for safety reasons, vessels and persons other than those participating in the works are prohibited from entering the Pike River near the Rumpagunyah Creek and Tanyaca Creek junction, downstream of the Mundic Creek junction.
