DEFINITION OF CLASSES

Class 1: Restricted to drilling operations in single non flowing aquifer systems.

Class 2: In addition to operating in Class 1 conditions, permits drilling operations in multiple non flowing aquifer systems.

Class 3: In addition to operating in Class 1 and 2 conditions, permits drilling operations in flowing aquifer systems.

**EXPLANATION OF RESTRICTED AND NATIONAL LICENCES**

Restricted SA Class 1 Licence is recognised only in South Australia.

A National Licence can be recognised by another mainland State or Territory and applicants for an equivalent licence in that State or Territory may only be examined on the relevant Water Act requirements.

Holders of a South Australia drillers licence may be permitted to drill in other states or territories, provided you have obtained Automatic Deemed Registration of your SA Well Driller’s Licence. For further information please contact the well drilling regulator in the state or territory in which you may wish to operate under Automatic Deemed Registration.
