River Murray Flow Report





Report #47/2021

Issued 10:00 am 3 December 2021

This supersedes the previous flow report issued by the Department for Environment and Water (DEW) on 26 November 2021. The next flow report will be provided on Friday 10 December 2021.

In this report, for ease of representation, large volumes of water are expressed in gigalitres (GL), while smaller volumes are expressed in megalitres (ML). One GL is equal to 1 000 ML.

QUARTER 2 METER READINGS DUE BY 31 DECEMBER 2021

If you hold a water resource works approval that includes a condition that requires you to provide quarterly meter readings to the Department for Environment and Water, please be reminded that meter readings for the Quarter 2 accounting period for 2021-22 (which ends on 31 December 2021) must be recorded within the first fourteen days of January 2022 and submitted to the department by 31 January 2022.


Your meter reading can be submitted via one of the following options:

Should you require assistance in supplying your meter reading, including how to complete the online meter reading form, please call the Berri office on (08) 85952053 and an officer of the department will be happy to assist you.

The department's preferred approach is to encourage and facilitate voluntary compliance. However, failure to voluntarily comply with the conditions of a water resource works approval may result in an expiation notice being issued.

FLOW OUTLOOK



The flow at the South Australian border is approximately 26 GL/day and will increase to around 28 GL/day over the coming week. It comprises:

- full December Entitlement Flow (7 GL/day);
- plus water for the environment (see below Environmental News);
- interstate trade adjustments;
- · Additional Dilution Flow (ADF); and
- Unregulated flow.

The flow over Lock 1 is approximately 28 GL/day and will remain around 28 GL/day over the coming week.

Over the coming weeks the flow to South Australia will be largely determined by rainfall and streamflow responses from upstream. With storages such as Lake Victoria, Hume and Menindee Lakes being close to capacity, there is limited ability to capture large increases in flow. If water cannot be captured in storages upstream this can increase the volume of unregulated flow at the South Australia border.

It is important to note that flow forecasts in this advice are based on the information available at the time of preparation. Advice may change as new gauging information becomes available or due to rainfall events or changed operations upstream.

ENVIRONMENTAL NEWS

The current flows from the River Murray and upstream tributaries, through to the Coorong, will provide a range of benefits for the environment in SA, including:

- providing 'flowing water habitat' to benefit native fish, animals and plants in the River Murray channel that have
 adapted to a riverine environment, including supporting conditions that favour spawning and recruitment of golden
 perch and Murray cod. Monitoring has detected golden perch eggs at various sites throughout the Lower Murray in
 recent weeks;
- providing for barrage releases to the Coorong to support a productive, food-rich environment for fish and birds and promote suitable conditions for estuarine fish to spawn;
- providing habitat for birds, frogs and threatened small-bodied native fish species in the Lower Lakes;
- maintaining good connections from the Coorong to the upstream areas of the River Murray, and its tributaries, to enable fish movement and migration;
- maintaining healthy water quality, salinity and water levels in the River Murray Channel and the Lower Lakes and Coorong;
- removing excess salt from the River Murray; and
- delivering a range of outcomes to wetlands in the Riverland via arrangements with Nature Foundation Limited, Renmark Irrigation Trust, Australian Landscape Trust, Accolade Wines Ltd and the Murraylands and Riverland Landscape Board.

MURRAY MOUTH

Dredging operations at the Murray Mouth commenced on 9 January 2015 to maintain connectivity (exchange of water) between the Coorong and the Southern Ocean. At 28 November 2021, a total of approximately 7 861 607 cubic metres of sand had been removed by dredging operations.

Both dredges are operating between the Goolwa and Tauwitchere channels 24 hours a day, seven days a week. Recently one dredge was removed for maintenance however will be back in operation as soon as possible.

Barrage releases combined with dredging have helped to maintain flow connectivity of the River Murray Channel to the Murray Mouth and have assisted in exporting salt from the river system.

There are a number of shallow zones in and adjacent to the Murray Mouth. Mariners should use caution when traversing the mouth area, follow all directions, reduce speed and avoid travelling at low tide. Mariners equipped with echo sounders should check depths regularly. Navigation through the Murray Mouth is only permitted during daylight hours. Exclusion Zones established around the dredging operations are in place to ensure public safety. Refer to Notice to Mariners No 42 of 2016 Notice 42.

There is a partial park closure in place for the northern tip of the Coorong National Park. For more information visit Coorong partial park closure notice.

BARRAGE OPERATIONS AND WATER LEVELS IN THE LOWER LAKES

The water level in Lake Alexandrina is approximately 0.78 m AHD and Lake Albert is approximately 0.77 m AHD.

As of Tuesday 30 November 2021, the weekly releases were approximately 204 GL. Gate openings at the barrages during the week can be seen in Table 1.

During adverse weather conditions, SA Water will operate the barrages to minimise the risk of seawater entering Lake Alexandrina, therefore minimising any negative salinity impacts from reverse flow events. Water levels and barrage operations are monitored closely by the South Australian Government, Murray-Darling Basin Authority and Commonwealth Environmental Water Office.




Figure 1: Releases being made from Tauwitchere barrage (Lake Alexandrina top left, Coorong bottom right. Looking towards the South East) (Geoff Gollasch)

BARRAGE RELEASES ARE NOW AVAILABLE ONLINE

River Murray water users and the general public can now access daily data on volumes of water released through the barrages in South Australia – all at the click of a mouse button.

The data, available via the Water Data SA online platform, will provide even more transparency in the role that the barrages play in river management.

At any time of day, the public will be able to see the total daily volume of water that has been released from the barrages to contribute to improved ecological outcomes throughout the system and more locally in the Coorong, Lower Lakes and Murray Mouth region.

Operation of the barrages is carefully managed to balance a number of objectives, including maintaining water quality and levels in the Lower Lakes, keeping continuous flow through the fishways, enhancing mouth openness and delivering water to where it's needed in the Murray estuary and Coorong.

In the coming months the data provided will be expanded to include the daily total at each barrage (Goolwa, Mundoo, Boundary Creek, Ewe Island and Tauwitchere), the number of gates open at each barrage and when changes have been made to gate configurations.




Figure 2: An example of barrage releases data that is now available on Water Data SA

RIVER VESSEL WASTE DISPOSAL STATIONS

Lock 3

The Lock 3 River Vessel Waste Disposal Station is currently out of commission due to an infrastructure failure. Investigations are underway to replace the station. In the interim river vessel users can contact Riverland Tank and Drain directly on 0412 839 392 for emptying of black and grey water in the Lock 3 area. Alternatively they can utilise the nearest alternative waste facility located at Waikerie. Normal boat waste (domestic or galley waste) can still be deposited at the Lock 3 facility at the present time.

NAVIGATION ISSUES

Sandbars in the vicinity of the Murray Mouth may cause navigation hazards. Mariners are advised to navigate with caution when operating in the area. Sandbars are also present along sections of the River Murray downstream of Locks 7 and 8 and in South Australia. All Mariners should be aware of the risk of submerged navigation hazards and should regularly check river depth.

ENVIRONMENTAL WATER OPERATIONS

Chowilla Floodplain and Weir and Lock 6

A low to mid-level operation of the Chowilla environmental regulator commenced in July 2021. The operation raised water levels in Chowilla Creek and through the Anabranch to a maximum height of 19.6 m AHD. The water level has now been lowered back to normal pool level (NPL).

The water level in Weir and Lock 6 was also raised in conjunction with the Chowilla Regulator and reached a maximum height of 19.68 m AHD. The water level is now back to NPL.

Pike Floodplain and Weir and Lock 5

Operations on the Pike Floodplain commenced 26 July 2021 and the operation reached its planned maximum level on 30 September 2021 (15.8 m AHD). The water level is now being lowered back to NPL.

The Lock 5 weir pool was temporarily raised by 50 cm to 16.8 m AHD in conjunction with the Pike floodplain watering to assist water flow through the floodplain. The water levels are now being lowered back to NPL.

Katarapko Floodplain and Weir and Lock 4

Operations on the Katarapko Floodplain also commenced 26 July 2021 and reached the maximum planned height of 13.2 m AHD on 15 September 2021, delivering water across about 800 hectares of the floodplain. Drawdown of water levels within the floodplain began and have now equalised with higher water levels in the main river channel. As the river level recedes, so will the water levels on the floodplain.

The Lock 4 weir pool level was raised for the duration of the event to 13.50 m AHD to assist with water flow into the Katarapko Creek system and is now back at NPL.

National Park access

There are some short term access restrictions and closures of some roads, trails and campsites due to the environmental watering at Katarapko and Chowilla floodplains. NEW PENALTIES FOR UNAUTHORISED OR UNLAWFUL WATER USE

All South Australian River Murray water users are reminded that they must remain within the available allocation on their water account at all times.

New penalty rates have been declared for taking water in excess of available allocation (unauthorised use) or without authorisation (unlawful use). These penalty rates will apply to any unauthorised or unlawful water use in the current quarter, being Quarter 2 of the 2021-22 water use year (between 1 October 2021 and 31 December 2021).
